REGIONAL DISTRICT OF NORTH OKANAGAN

BYLAW No. 1148

WHEREAS, pursuant to Section 934.1 of the Municipal Act, the Regional Board may, by by-law, provide for the enforcement of by-laws by municipal ticket information;

AND WHEREAS, the Regional Board deems it expedient to authorize the use of the municipal ticket information for the enforcement of certain by-laws, to designate persons as By-Law Enforcement Officers, to authorize the use of certain words or expressions to designate certain by-law offenses and to set certain fine amounts;

NOW THEREFORE, the Regional Board of the Regional District of North Okanagan, in open meeting assembled enacts as follows:

- 1. Schedules 'A' through 'K' attached hereto form part of this bylaw.**
2. The by-laws listed in Column 1 of Schedule "A" of this by-law as amended from time to time, may be enforced by means of a ticket in the form prescribed.
3. The persons appointed to the job positions or titles listed in Column 2 of Schedule "A" of this by-law are designated as By-Law Enforcement Officers for the purpose of enforcing the by-laws listed in Column 1 opposite the respective job positions.
4. The words or expressions set forth in Column 1 of Schedule "B" through to Schedule "G" of this by-law designate the offense committed under the by-law section number appearing in Column 2 opposite the respective words or expressions.
5. The amounts appearing in Column 3 of Schedule "B" through to Schedule "G" of this by-law are the fines set for the corresponding offenses designated in Column 1.
6. This by-law may be cited as "***The Regional District of North Okanagan Ticket Information Authorization By-Law No. 1148, 1993.***"
7. This by-law shall take effect upon the date of its adoption.
