**RCMP Contract—Technical Briefings Update** 

#### 1. Background

A new RCMP contract has been agreed to in principle between the Province and the federal government. Technical briefing sessions have been organized to inform local government about the new the RCMP agreement.

The provincial Ministry of Public Safety & Solicitor General will lead the technical briefings. Deputy Minister Lori Wanamaker, lead negotiator for the Province in the contract negotiations; and Mayor Peter Fassbender, the UBCM-appointed local government representative on the provincial negotiating team, will outline the details of the new contract.

The technical briefings will be of particular interest to elected officials, administrators and chief financial officers who are currently part of the RCMP contract and paying for the operation of a detachment office. Those local governments that are policed by the Provincial Force—small communities and rural areas—will also have an opportunity to raise their issues.

Please note that these sessions are confidential briefings intended solely for local government elected officials and senior staff.
