RE: ORDER Issued March 11, 2011, under the Drinking Water Protection Act is RESCINDED

In the matter of the outstanding ORDER issued March 11, 2011 to the Regional District of North Okanagan Board Chair and Directors on behalf of the Greater Vernon Water Utility, our office has received the 2012 Master Water Plan, an Application for Filtration Deferral for the Kalamalka Lake Source and, the supporting Financial Plans on June 28, 2013. Subsequently, the Duteau Creek Water Treatment Plan - Filtration Treatment Pilot Testing Report was submitted for review November 28, 2013, which outlined a general description of a chemically assisted granular media filtration technology. All of these documents, along with the current source assessment response planning which is currently in progress, serve to demonstrate clear commitment for a long term improvement strategy towards achieving the BC Drinking Water Treatment Objectives.

Pursuant to Section 26 of the *Drinking Water Protection Act* [SBC 2001] Chapter 9, I Gordon Moseley, CPHI(C), as delegated the authority of a Drinking Water Officer under *The Act*, have reviewed the aforementioned documents against the terms and conditions of the current ORDER, and am of the opinion that all conditions have now been satisfactorily met. The ORDER is now officially rescinded, effective immediately.

Please note the rescinding of this ORDER does not impact the requirements of any of the existing Conditions' on Permit to Operate the Greater Vernon Water Utility system.
