193 North Fork Road, Electoral Area "E" (10-0051-E-RZ)

Bylaw 2432, 2010 – Rezoning

Purpose: To rezone a 1.5 ha portion of the property legally described as Lot 1, Sec. 27, Twp. 57, ODYD, Plan 25356, Except Plan 31780 and located at 193 North Fork Road, Electoral Area "E" from the Non-Urban (N.U) Zone to the Small Holding (S.H) Zone to permit a potential one lot plus remainder subdivision.
