BYLAW No. 1600

A bylaw to establish a local service for the supply, conveyance and distribution of community water to the Gunter-Ellison Road area of Electoral Area "F"

WHEREAS the Regional Board of the Regional District of North Okanagan (the "District") has been requested to establish a local service for the purpose of the supply, conveyance and distribution of community water to a defined service area along Gunter-Ellison Road in Electoral Area "F":

AND WHEREAS pursuant to section 798(1)(b) of the *Municipal Act* (the "Act"), a regional district may establish a local service for the supply, conveyance and distribution of water;

AND WHEREAS the City of Enderby is prepared to supply water to the Gunter-Ellison Road area;

AND WHEREAS a valid petition has been received and certified by the Secretary of the District pursuant to section 812 [petition for services] of the Act;

AND WHEREAS pursuant to section 811 [consent on behalf of electoral area electors] of the Act, the Regional Board has waived the assent requirement, and the consent of the electoral area director for Electoral Area "F" has been received;

NOW THEREFORE, the Board of the Regional District of North Okanagan, in open meeting assembled, hereby ENACTS AS FOLLOWS:


- 1. This Bylaw may be cited as the "Gunter-Ellison Road Water Local Service Establishment Bylaw No. 1600, 2000".
- 2. The Regional District of North Okanagan hereby establishes in Electoral Area "F", a local service for the supply, conveyance and distribution of water to the Gunter-Ellison Road area.
- 3. The service area shall be known as the "Gunter-Ellison Road Water Local Service Area", and shall be comprised of that tract of land located in Electoral Area "F" as outlined on the map attached to this bylaw as Schedule "A".
- 4. The participating area is part of Electoral Area "F".

- 5. The District is hereby authorized to carry out, or cause to be carried out, and to provide the local service of supply, conveyance and distribution of water in the said local service area including the purchase of all easements and appurtenances incidental thereto located in and for the service area.
- 6. The cost of providing the service shall be recovered by one or more of the following:
 - a. the requisition of money under section 816 [cost recovery for local services] of the Act to be collected by a property value tax imposed in accordance with section 825 [collection in electoral areas] of the Act; or
 - b. the requisition of money under section 816 of the Act to be collected by a parcel tax as provided in section 825 of the said Act; and
 - c. the imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering the costs.
- 7. The maximum amount that may be requisitioned annually under section 816(1)(a) of the Act for this service shall not exceed the greater of \$11,000.00, or the product of a property value tax rate of \$7.40 for each \$1,000 of net taxable value of land and improvements in the service area.
- 8. The District may provide the said service through its own resources or by entering into contractual agreements.
