Assumption of Risks

I understand that the training activities my child is participating in at the Intermunicipal Fire Training Centre may include but are not limited to:; boarding, riding on or alighting from vehicles or apparatus; the utilization and operation of specialized equipment, including pumps, ladders, saws, fire suppression equipment, self-contained breathing apparatus, hydraulic, gas powered and hand tools; the utilization and operation of specialized training facilities, including self-rescue props, search and rescue props, gas props, a scaffolding tower, a burn building, and confined spaces; and exposure to fire, water, chemicals and heat (the "**Activities**").

I am aware that my child's participation in the Activities will involve many inherent risks, dangers and hazards which include but are not limited to: boarding, riding on, or alighting from vehicles or apparatus; the utilization or operation of specialized equipment and facilities; equipment malfunction; falling or loss of balance; exposure to fire, water, chemicals and heat; negligence on the part of other persons attending or participating in the training and/or demonstration; and negligence on the part of the officers, employees, agents or volunteers of the Province of BC, Intermunicipal Fire Training Centre, City of Vernon, District of Coldstream, Village of Lumby, Township of Spallumcheen, City of Armstrong, City of Enderby or Regional District of North Okanagan or their staff.

I am also aware that the risks, dangers and hazards referred to above may arise or occur at any time and without warning.

I freely acknowledge and accept all such risks, dangers and hazards associated with my child's participation in the Activities at the Intermunicipal Fire Training Centre, including without limitation the possibility of injury, death, property loss or damage resulting therefrom.

Release of liability, waiver of claims and indemnity agreement

In consideration of my child being permitted to participate in the Activities at the Intermunicipal Fire Training Centre, I hereby agree to the following:

1. TO WAIVE any and all claims that I have or may in the future have against the Province of BC, Intermunicipal Fire Training Centre, City of Vernon, District of Coldstream, Village of Lumby, Township of Spallumcheen, City of Armstrong, City of Enderby or Regional District of North Okanagan and their officers, employees, agents, volunteers and representatives (all of whom are hereafter collectively referred to as "the Releasees"), related in any way to my child's participation in the Activities.
2. TO RELEASE the Releasees from any and all liability for any loss, damage, personal or bodily injury, permanent disability or death that my child suffers as a result of their participation in the Activities and due to any cause whatsoever including negligence, breach of contract or breach of any statutory or other duty of care, including any duty of care owed under the Occupiers' Liability Act, R.S.B.C. 1979, c.303, on the part of the Releasees;
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my child's participation in the Activities.
4. In no event will any of the Releasees be liable for any loss, damage, personal or bodily injury, permanent disability or death nor for any loss or damage (including indirect or consequential damages) that my child suffers whether attributable to or arising out of my child's participation in the Activities or by reason of any matter or thing done or permitted.
5. In entering into this Agreement, I am not relying upon any oral or written representations or statements made by Releasees other than what is set forth in this Agreement.

Acknowledgement of Understanding

I ACKNOWLEDGE that I am at least 19 years of age and have read and understood this Agreement and I am aware that by signing this Agreement I am waiving certain legal rights and agree that this Indemnity will be binding upon me (as parent or guardian), my next of kin, administrators, successors or assigns.
