

REGIONAL DISTRICT OF NORTH OKANAGAN

BY-LAW NO. 690

A By-law to establish a defined area within Electoral Areas "A", "B", and "C" of the Regional District of North Okanagan for the purpose of providing street lighting services

WHEREAS the Regional Board of the Regional District of North Okanagan has been requested to establish a defined area for the purpose of providing street lighting to parts of Electoral Areas "A", "B", and "C" near clusters of mailboxes and at critical intersections;

AND WHEREAS by Supplementary Letters Patent dated the 15th day of May, 1975, the Regional Board was authorized to establish, maintain, and operate a street lighting service and to define areas of an electoral area to be a street lighting service unit;

NOW THEREFORE the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

1. (a) The Regional Board is hereby empowered and authorized to establish in Electoral Areas "A", "B", and "C" a defined area known as the 'Electoral Areas "A", "B", and "C" Street Lighting Service Unit' and that such area shall be comprised of that tract of land described in Schedule "A" attached hereto and forming part of this by-law;
(b) To undertake and carry out or cause to be carried out and provide street lighting in and for the said street lighting service unit and to do all things necessary in connection therewith;
2. The entire cost of providing street lighting shall be borne by the owners of land in the said street lighting service unit and a sum sufficient therefore shall be levied and raised in the manner prescribed in the Municipal Act in each year commencing with the year 1986 for such period of time as necessary, on all lands and improvements on the basis of assessment as fixed for taxation for school purposes only by special Act within the said street lighting service unit.
3. The street lighting service unit established by this by-law may be merged with any other service unit, whether contiguous or not, in the manner provided in Section 677(3) of the Municipal Act;
4. This By-law may be cited as the "Electoral Areas 'A', 'B', and 'C' Street Lighting Services By-law No. 690, 1986".
