**NOTE:**

1. Water use during off season will be charged per the current Greater Vernon Water Rates Imposition Bylaw (with application – water used 30 days before or after the irrigation season will be included in the property allocation and if applicable, over consumption rates will apply).
2. Irrigation Season means the five (5) month period from approximately mid-April to mid-September, as may be modified by drought or other conditions as determined by the General Manager from time to time.
3. GVW does not guarantee irrigation turn-on will occur on the requested date.
4. Early Turn-on applications received within three (3) business days prior to the advertised irrigation turn-on date are not likely to be turned-on as requested due to operator time constraints. Application fee will not be reimbursed.
5. Your application **may be denied** for one of the following reasons:
 

a) Operational issues;	b) Water storage in reservoirs is low;
c) Summer pumping conditions must be maintained if approved;	d) Drought concerns;
e) Water License limitations; or	f) Other.
6. The irrigation services of applicants for the year-round option may be turned off for any reason in Note 5 and the RDNO reserves the right to end the year-round option at any time without notice. It is the responsibility of the applicant to notify the RDNO to initiate turn-off or turn-on.

- I acknowledge that GVW is in drought conditions and if my application is approved, my water service may be turned off or flow/water use could be restricted at any time without notice based on storage/drought conditions with the application fee being **non-refundable**.
