Please Note:	 The signatory is of the age of majority for BC (19yrs), acknowledges the declared state of emergency giving rise to the evacuation order for the specified location, Is the owner/tenant of the premises and not an employee of the farm, as defined by the Workers Compensation Act and Regulation BC. The signatory will monitor the current state of the emergency to assure their safety, checking media and other communication means for officially released updates. Roadblocks into an Evacuation Order Area may be in place, and the timing for gaining access and egress from the Order Area will depend upon the emergency. By completing this form, your name will be on a registry, and if logistically possible, you will be able to access your property. Your reason to remain on your property is to maintain essential services, e.g., animal health and well-being; it may not be possible to ensure business continuity, as 					
emergency operations may change for life safety reasons until the order has lifted.
