REGIONAL DISTRICT OF NORTH OKANAGAN

BYLAW No. 1663

A bylaw to establish a service of Fire Dispatch to serve the fire protection services operated within the Regional District of North Okanagan with such service to be separate and apart from the 911 Emergency Telephone Service

WHEREAS by Supplementary Letters Patent dated February 24, 1988 the Regional District of North Okanagan (the "District") was granted the function of Emergency Telephone Response Service within the entire Regional District;

AND WHEREAS by Bylaw No. 779, "*Fire Department Dispatch Service Agreement Bylaw No. 779, 1988*", the Regional District entered into an agreement with the City of Vernon to provide fire department dispatch to all fire departments within the North Okanagan Regional District;

AND WHEREAS by Bylaw 1160, "*Regional District of North Okanagan 911 Extended Service Conversion and Establishment Bylaw No. 1160, 1993*" the service of Emergency Telephone Response was converted to an extended service, and included provision for fire department dispatch;

AND WHEREAS the Regional Board wishes to separate the operating costs of fire department dispatch out of the Emergency Telephone (911) service and establish it as a separate service;

AND WHEREAS the proposed cost of the service is less than an amount equivalent to \$0.50 per \$1,000 of net taxable value of land and improvements in the service area;

AND WHEREAS a fair estimate of the total number of electors in the Electoral Area service areas is 7,822 (Electoral Areas "B" and "C" 4,816, Electoral Area "D" 1,601 and Electoral Area "F" (Shuswap River Fire Protection Area) 1,405);

AND WHEREAS the Board has obtained the required assent of the electors within Electoral Areas "B", "C", "D" and "F" of the Regional District for the establishment of this service, under the provisions of the *Local Government Act* (the "Act") [s.801.3 - *Approval of electors by counter petition*];

AND WHEREAS the Board has obtained the consent of the Councils of the City of Enderby, City of Armstrong, Township of Spallumcheen, City of Vernon, District of Coldstream and the Village of Lumby under the provisions of the Act [s.801.4 – *Consent on behalf of municipal electors*];

NOW THEREFORE, the Regional Board of the Regional District of North Okanagan, in open meeting assembled, **ENACTS AS FOLLOWS:**

TITLE

1. This bylaw may be cited as the "***North Okanagan Fire Dispatch Establishment Bylaw No. 1663, 2000***".

ESTABLISHMENT

- ~~2. The Board of the Regional District of North Okanagan hereby establishes the “North Okanagan Fire Dispatch Service” to provide the service of fire department dispatch to all fire departments operating within the North Okanagan Regional District, with the service area as described in Section 4 of this bylaw.~~
- 2. The Board of the Regional District of North Okanagan hereby establishes the “North Okanagan Fire Dispatch Service” to provide the service of fire department dispatch to all fire departments operating within the service area as described in Section 4 of this bylaw.**

SCOPE OF SERVICE

3. The service established by this bylaw is to provide a central fire department dispatch service operating within the service area as described in Section 4.

SERVICE AREA

- ~~4. The service area for the service established by Section 2. shall encompass all of the City of Armstrong, City of Enderby, District of Coldstream, Township of Spallumcheen, City of Vernon, Village of Lumby and parts of the Electoral Areas “B”, “C”, “D” and “F” as shown in the Fire Protection Service Area maps as attached to and forming part of this bylaw as Schedules ‘A’, ‘B’, ‘C’, ‘D’ and “E” representing the follows fire protection areas:
“B” and “C” “BX Swan Lake Fire Protection Service Area” (map ‘A’);
“B” “Okanagan Landing Fire Protection Service Area” (map ‘E’)
“C” “Silver Star Village Fire Protection Service Area” (map ‘B’);
“D” “Lumby & District Fire Protection and Control Service Area” (map ‘C’); and
“F” as covered by the “Shuswap River Fire Protection District” (map ‘D’).~~
- 4. The service area for the service established by Section 2 shall encompass all of the City of Armstrong, City of Enderby, District of Coldstream, Township of Spallumcheen, and Village of Lumby and parts of Electoral Areas “B”, “C”, “D” and “F” as shown on Schedules “A”, “B”, “C” and “D” attached hereto and forming part of this bylaw.**

PARTICIPATING AREA

- ~~5. The participating areas for the service established by Section 2. shall be the City of Armstrong, City of Enderby, District of Coldstream, Township of Spallumcheen, City of Vernon, Village of Lumby and Electoral Areas “B”, “C”, “D” and “F”, of the Regional District of North Okanagan.~~
- 5. The participating areas for the service established by Section 2 shall be the City of Armstrong, City of Enderby, District of Coldstream, Township of Spallumcheen, Village of Lumby and Electoral Areas “B”, “C”, “D” and “F”.**

COST RECOVERY

6. The annual cost of providing the service shall be recovered by the requisition of money under Sections 805 and 806 of the *Local Government Act* to be collected as a property value tax to be levied on improvements only and collected in accordance with Sections

805.1 and 806.1 of the Act.

- 7. The annual cost of this service shall be apportioned amongst the participants on the basis of the converted value of improvements only for hospital purposes in those areas.

MAXIMUM REQUISITION

- 8. The maximum amount which may be requisitioned annually for this service shall not exceed the greater of \$300,000.00 or the product of a levy of \$0.07 for each \$1,000 of net taxable value of land and improvements in the service area.

GENERAL

- 9. The Regional District may provide the service through its own resources or by entering into contractual agreements.

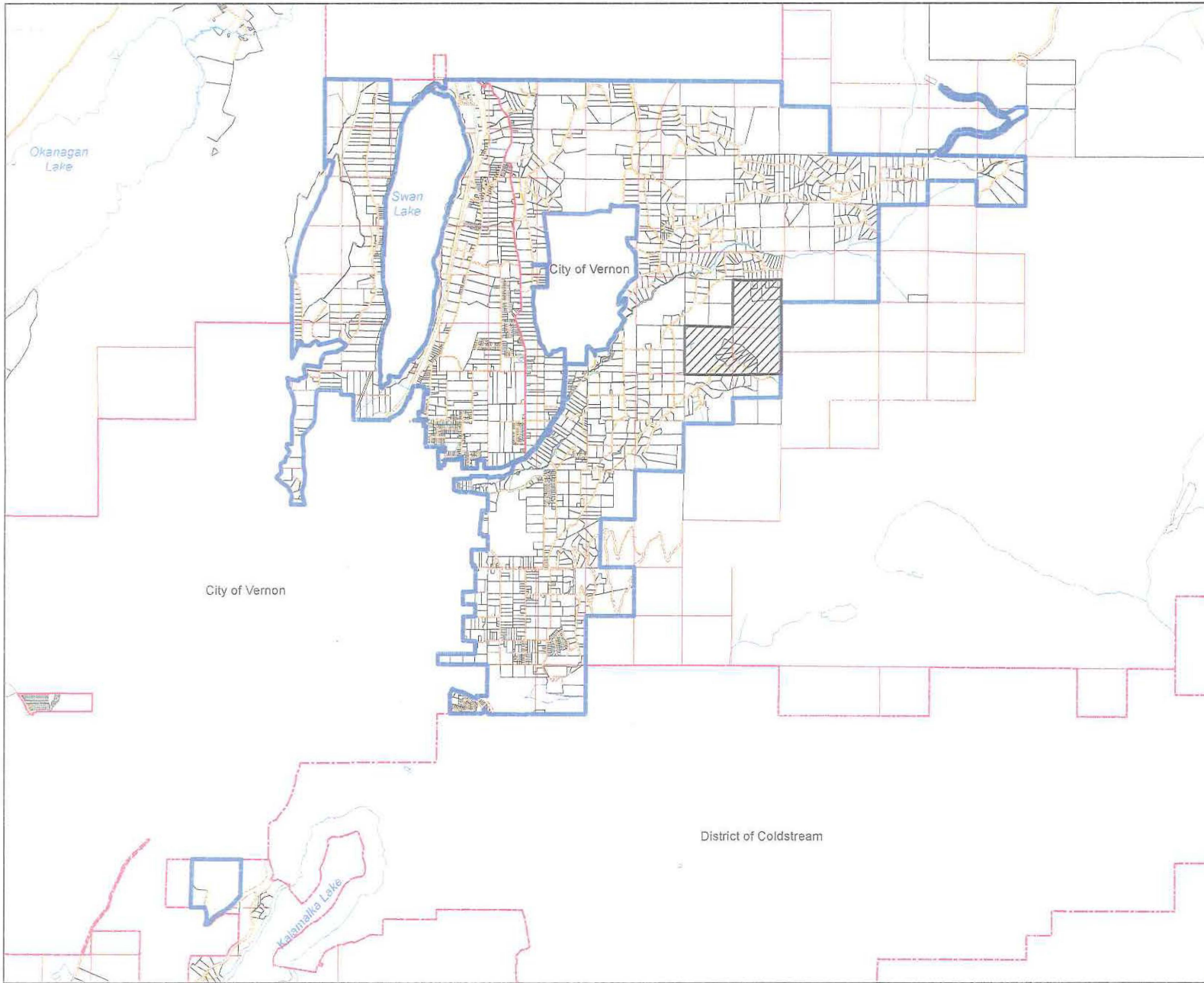

Bylaw No. 2900, 2021

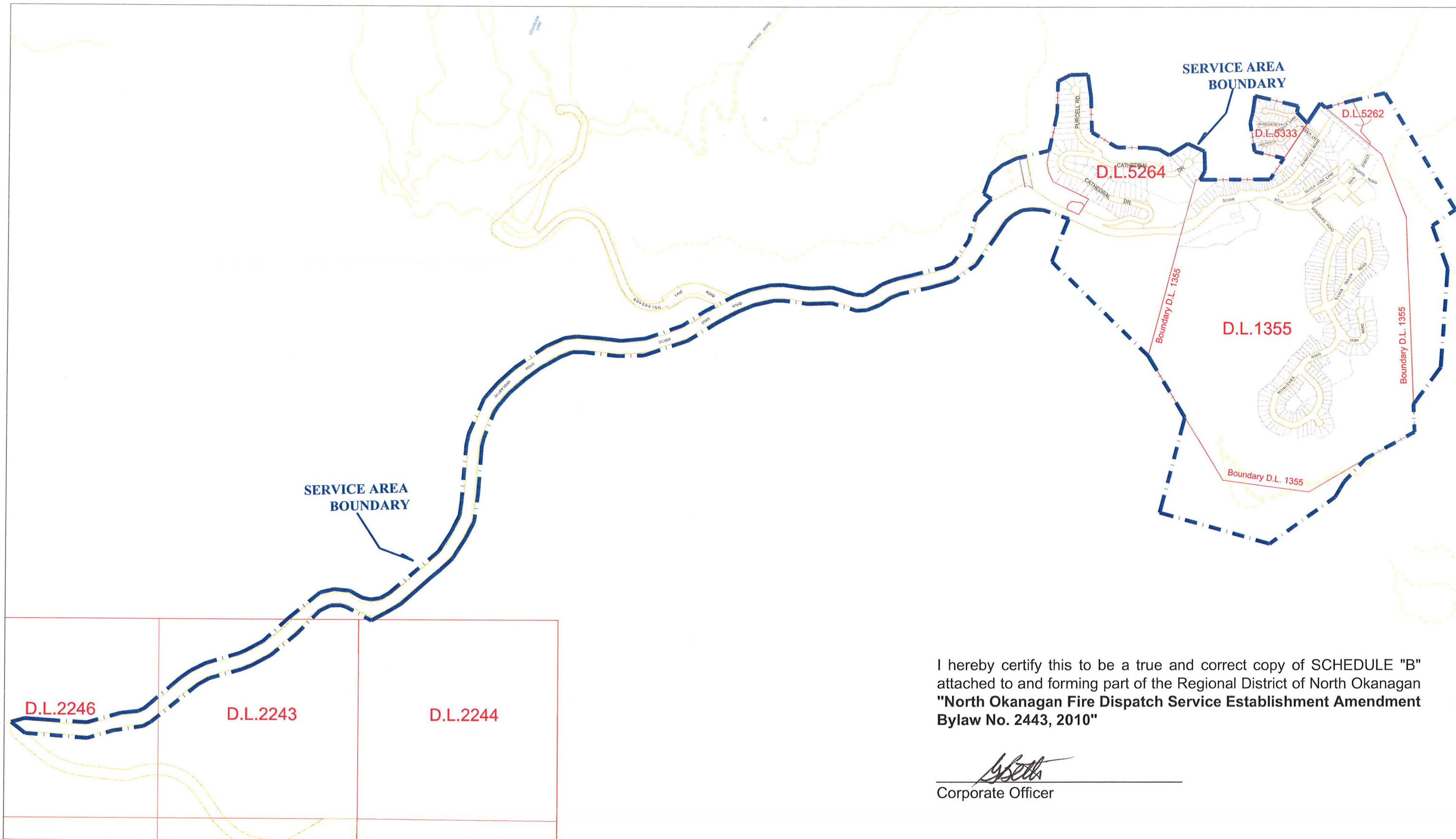

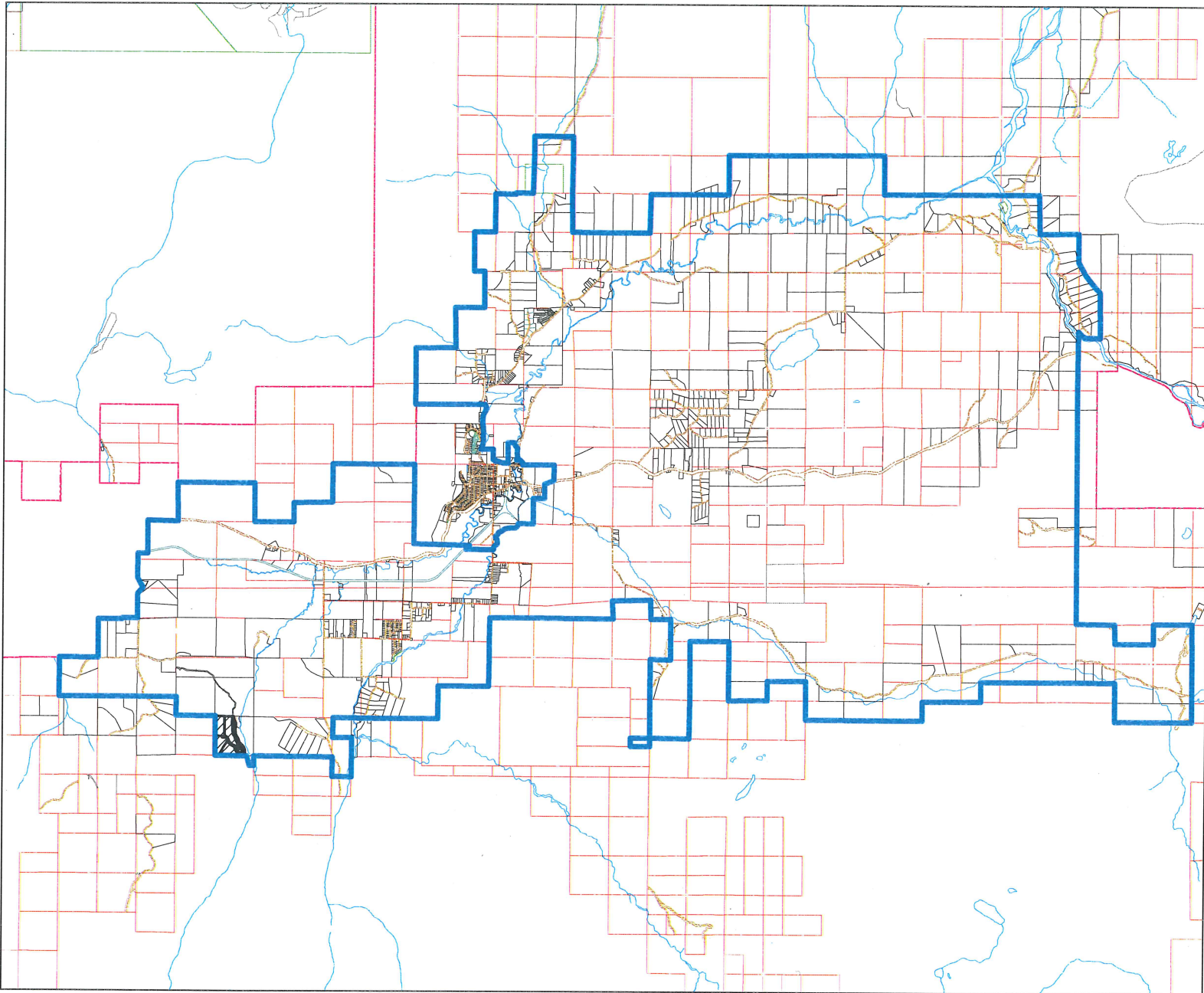

Establishment Amendment Bylaw No. 2969, 2023

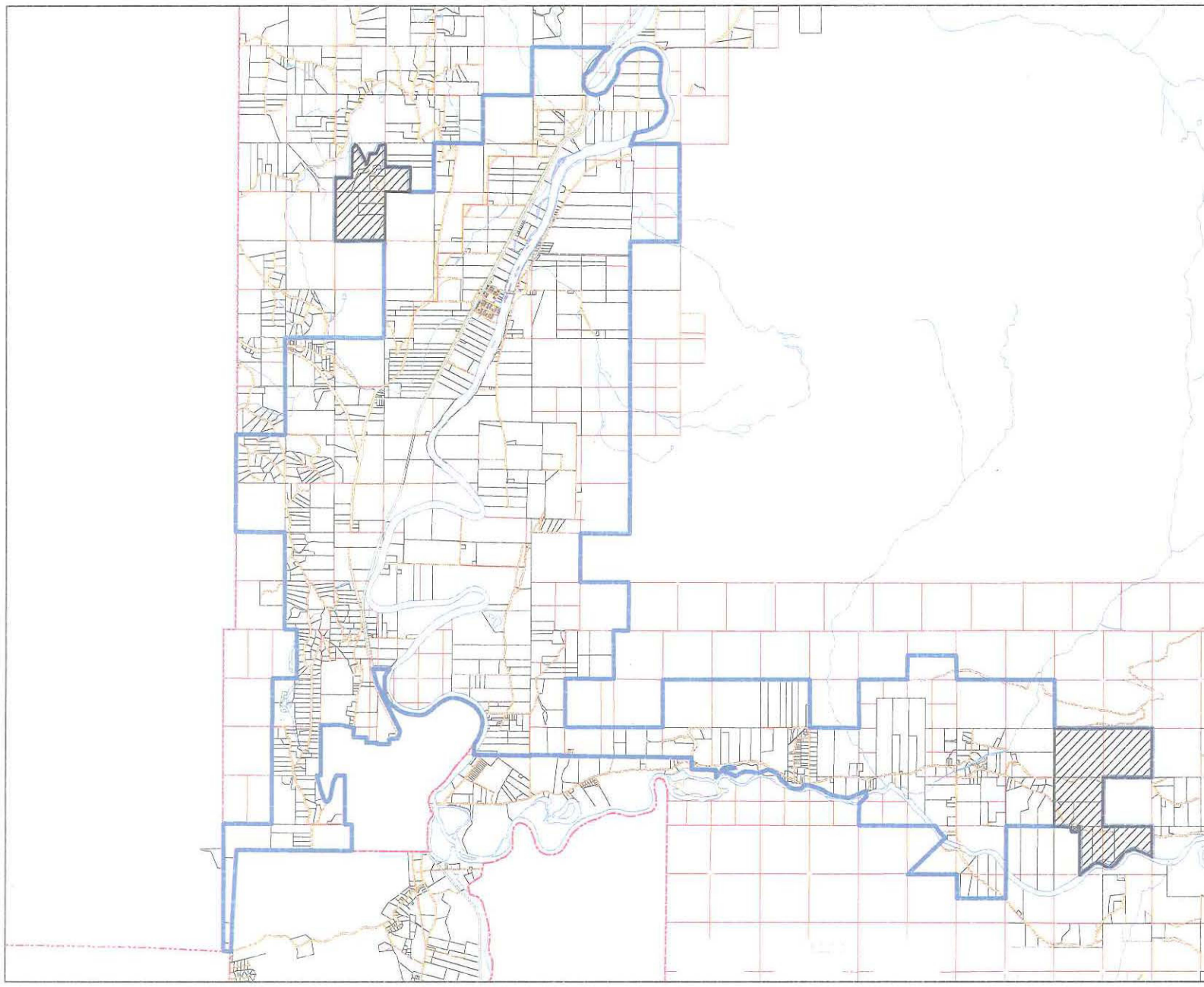
