REGIONAL DISTRICT OF NORTH OKANAGAN

BYLAW No. 1262

A bylaw to establish a local service area within the Corporation of the City of Vernon, the Corporation of the District of Coldstream, and Electoral Areas "B" and "C" of the Regional District of North Okanagan for the purpose of providing the local service of regional water supply

WHEREAS Order-In-Council No. 1336 dated October 27, 1994 provides that the Vernon Irrigation District, incorporated by Letters Patent issued December 9, 1920 be dissolved and a local service area of the Regional District of North Okanagan be established for regional water supply;

AND WHEREAS the said Order-In-Council requires that the Regional District of North Okanagan adopt a bylaw pursuant to Section 773(2) of the *Municipal Act* establishing the local service of a regional water supply as provided by Section 788(1)(b) of the *Municipal Act* for the Corporation of the City of Vernon, the Corporation of the District of Coldstream and Electoral Areas "B" and "C" of the Regional District of North Okanagan no later than February 28, 1995;

NOW THEREFORE, the Regional Board of the Regional District of North Okanagan in open meeting assembled, enacts as follows:

1. ~~The water supply service provided by the former Vernon Irrigation District is hereby established as a local service of regional water supply to be known as the "Greater Vernon Regional Water Supply Local Service Area".~~
2. ~~The service area for the local service established by Section 1. shall encompass those parts of the Corporation of the City of Vernon, the Corporation of the District of Coldstream, and Electoral Areas "B" and "C" of the Regional District of North Okanagan as shown on the plan marked as Schedule "A", attached to and forming part of this bylaw and shall include the aforementioned municipalities and electoral areas as participating areas.~~
3. ~~The costs of providing the service established under Section 1. shall be recovered by:
 - (a) ~~the requisition of money under Section 809 and 809.1 of the *Municipal Act* to be collected by a property value tax as provided in Section 810(1) and 810.1(1) of the said Act; on land, on improvements only, or on land and improvements; or~~
 - (b) ~~the requisition of money under Section 809 and 809.1 of the *Municipal Act* to be collected by a frontage or parcel tax as provided in Section 810(2) and 810.1(2) of the said Act; and~~
 - (c) ~~the imposition of fees and charges that may be fixed by separate bylaw for the purpose of recovering the costs.~~~~
4. ~~The maximum amount that may be requisitioned annually under Section 804(1)(a) shall not exceed Three Million Dollars (\$3,000,000.00).~~

SCOPE OF SERVICE

1. ***The Greater Vernon Water Service includes:***
 - (a) ***acquiring and constructing water supply and distribution facilities, including without limitation reservoirs, wells, intakes, mains, pipes, pumps, ancillary water transmission lines, water reclamation facilities and water treatment facilities;***
 - (b) ***operating, maintaining, repairing and replacing water supply and distribution facilities;***
 - (c) ***acquiring, improving and maintaining land, buildings, equipment, vehicles and other real and personal property for water supply and distribution purposes;***
 - (d) ***acquiring and holding water licences;***
 - (e) ***planning for water supply and distribution needs within the service area;***
 - (f) ***providing water in bulk to other local authorities for distribution to consumers;***
 - (g) ***reclaiming water from waste treatment, agricultural, industrial and other facilities; and,***
 - (h) ***carrying out any other function which involves water supply or distribution.***

SERVICE AREA

2. ***The service area for the Greater Vernon Water Service consists of all of the City of Vernon, all of the District of Coldstream and those parts of Electoral Areas "B" and "C" shown outlined in black on Schedule "A" to this bylaw.***

PARTICIPATING AREAS

3. ***The participating areas for the local service are the City of Vernon, District of Coldstream, and Electoral Areas "B" and "C".***

COST RECOVERY

4. ***The annual cost of providing the service shall be recovered by one or more of the following:***
 - (a) ***the requisition of money under Sections 805 and 806 of the Local Government Act to be collected as a property value tax to be imposed in accordance with Division 4.3 of Part 24 of the Local Government Act and to be collected in accordance with Sections 805.1 and 806.1 of the Act;***

- (b) *parcel taxes to be imposed in accordance with Division 4.3 of Part 24 of the Local Government Act;*
- (c) *the imposition of fees and other charges; and*
- (d) *revenues received by way of agreement.*

5. *The annual cost of the service shall be apportioned among the participants on the basis of the converted value of land and improvements in those areas.*

MAXIMUM REQUISITION

6. *The maximum amount that may be requisitioned annually for this service shall be the greater of \$0.50 per \$1,000.00 on the net taxable value of land and improvements included in the service area or \$1,500,000.00 whichever is greater.*

REGIONAL BOARD VOTING

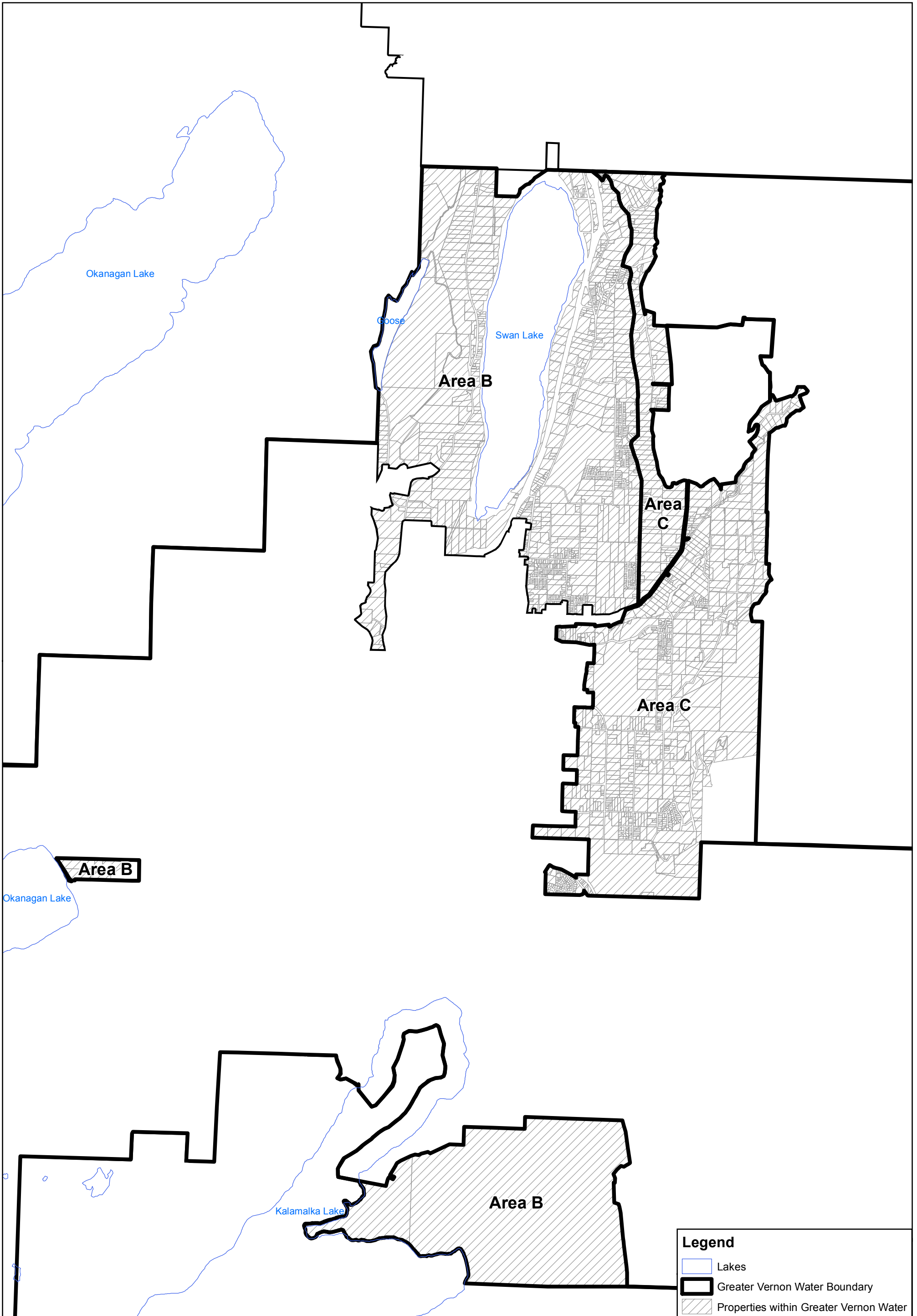
7. *In relation to resolutions and bylaws respecting the administration and operation of the service, including bylaws regulating the service, each director who represents a participant in the service shall be entitled to one vote.*

8. This Bylaw be cited for all purposes as *"Regional District of North Okanagan - Greater Vernon Regional Water Supply Local Service Establishment Bylaw No. 1262, 1994"*.

Okanagan Lake


