## **REGIONAL DISTRICT OF NORTH OKANAGAN**

### **By-Law No. 1013**

A by-law to convert and establish the "Okanagan Landing Street Lighting Service Units Merger By-Law No. 480, 1982" as amended, as a local service area and to merge it with the local service areas established by By-Law Nos. 887, 931, 932, 933, 938 and 957 into a single local service area for street lighting.

**WHEREAS** the Regional Board of the Regional District of North Okanagan under the authority of Supplementary Letters Patent dated the 15 day of May, 1975, established a specified area for the purpose of providing street lighting by the "Okanagan Landing Street Lighting Services Units Merger By-Law No. 480, 1982", which was further amended by By-Law Nos. 530, 731, 747, 748, 766, 790, and 808;

**AND WHEREAS** the Regional Board of the Regional District of North Okanagan, pursuant to Section 788 of the Municipal Act, established local service areas for street lighting by By-Law Nos. 887, 931, 932, 933, 938, and 957;

**AND WHEREAS** it is now deemed desirable to convert the said specified area to a local service area and merge it with the aforementioned local service areas into one local service area for convenience of administration pursuant to Section 802(1.1) of the Municipal Act;

**NOW THEREFORE** the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:


1. The "Okanagan Landing Street Lighting Service Units Merger By-Law No. 480, 1982", together with its amendments by "Briggs Road Street Lighting Service Unit By-Law No. 530, 1983", "Cunningham Street Lighting Services Unit By-Law No. 731, 1987", "Holbrook Street Lighting Services Unit By-Law No. 747, 1987", "Wallace Street Lighting Service Unit By-Law No. 748, 1987", "McIntosh, Pearson, and Spartan Roads Street Lighting Service Unit By-Law No. 766, 1987", "Bella Vista, Orchard Hill, Sunnyview, and Southwind Street Lighting Service Unit By-Law No. 790, 1988", "Street Lighting Name Change By-Law No. 808, 1988", are hereby converted and established as a local service area for street lighting, pursuant to the provisions of Section 767 of the Municipal Act.
2. The said local service area, together with the service areas established by "Elwyn Road Street Lighting Local Service Area Establishment By-Law No. 887, 1990", "Rolling Hills Subdivision Street Lighting Local Service Area Establishment By-Law No. 931, 1990", "Bolduc Road Street Lighting Local Service Area Establishment By-Law No. 932, 1990", "Lester Street Street Lighting Local Service Area Establishment By-Law No. 957, 1990", are hereby converted and established as a local service area for street lighting, pursuant to the provisions of Section 767 of the Municipal Act.

2. ... 1990", "B.X. Villa Subdivision Street Lighting Local Service Area Establishment By-Law No. 933, 1990", "Schram Road Street Lighting Local Service Area Establishment By-Law No. 938, 1990", "Bryden Road Street Lighting Local Service Area Establishment By-Law No. 957, 1991", are hereby merged, pursuant to the provisions of Section 802(1.1) of the Municipal Act.
3. The boundaries of the merged areas, which are not contiguous, are those particularly described on *Schedule "A"* attached hereto and forming part of this by-law.
4. The maximum amount that may be requisitioned for annual operating costs shall not exceed the product of a levy of \$0.50 for each \$1,000.00 of net taxable value of land and improvements included in the service area.
5. The areas merged under this by-law are deemed to be one local service area known as the *Areas "A", "B", and "C" Neighbourhood Street Lighting Local Service Area*.
6. This by-law may be cited as the "Areas "A", "B", and "C" Neighbourhood Street Lighting Local Service Area Merger By-Law No. 1013, 1991".


