

## REGIONAL DISTRICT OF NORTH OKANAGAN

### By-Law No. 1014

A by-law to convert and establish the Pemberton Street Lighting Service Unit as a local service area and merge it with the Whitevale Subdivision Street Lighting Local Service Area

---

**WHEREAS** under authority of Supplementary Letters Patent dated the 15 day of May, 1975, the Regional Board of the Regional District of North Okanagan, established a street lighting service unit by the "Pemberton Street Lighting Service Unit By-Law No. 759, 1987" ;

**AND WHEREAS** under authority of Part 24 of the Municipal Act, the Regional Board of the Regional District of North Okanagan, established local service areas for street lighting by "Whitevale Subdivision Street Lighting Local Service Area Establishment By-Law No. 945, 1991";

**AND WHEREAS** it is now deemed desirable to convert and establish the said service unit as a local service area, pursuant to Section 767(4) of the Municipal Act, and to merge it for the convenience of administration with the Whitevale Subdivision Street Lighting Local Service Area, pursuant to Section 802(1.) of the Municipal Act;

**NOW THEREFORE** the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:


1. The street lighting service unit established by the "Pemberton Street Lighting Service Unit By-Law No. 759, 1987" is hereby converted as a local service area.
2. The said street lighting service unit, now converted and established as a local service area, together with the Whitevale Subdivision Street Lighting Local Service Area are hereby merged.
3. The boundaries of the merged areas, which are not contiguous, are those more particularly described on *Schedule "A"* attached hereto and forming part of this by-law.
4. The maximum amount that may be requisitioned for annual operating costs shall not exceed the product of a levy of \$0.50 for each \$1,000 of net taxable value of land and improvements included in the service area.
5. The areas merged under this by-law are deemed to be one local service area known as the *Lumby Rural Street Lighting Local Service Area*.


6. This by-law may be cited as the "Lumby Rural Street Lighting Local Service Area Merger By-Law No. 1014, 1991".
