REGIONAL DISTRICT OF NORTH OKANAGAN

BYLAW NO. 1264

A bylaw to establish a local service within a portion of Electoral Area "D" of the Regional District of North Okanagan to provide water supply and distribution

WHEREAS Order-In-Council No. 1336 dated October 27, 1994 provides that the Vernon Irrigation District, incorporated by Letters Patent issued December 9, 1920 be dissolved and a local service area of the Regional District of North Okanagan be established for water supply and distribution;

AND WHEREAS the said Order-In-Council requires that the Regional District of North Okanagan adopt a bylaw pursuant to Section 773(2) of the *Municipal Act* establishing the local service of water supply and distribution as provided by Section 788(1)(b) of the *Municipal Act* for a portion of Electoral Area "D" of the Regional District of North Okanagan no later than February 28, 1995;

NOW THEREFORE, the Regional Board of the Regional District of North Okanagan in open meeting assembled, enacts as follows:

1. The water supply and distribution service provided by the former Vernon Irrigation District is hereby established as a local service and the service area shall encompass and include that portion of Electoral Area "D" shown outlined on the plan attached as Schedule "A" to this bylaw and be known as "Electoral Area "D" Regional Water Supply and Distribution Local Service Area".
2. The costs of providing the service established under Section 1. shall be recovered by:
 - (a) the requisition of money under Section 809 and 809.1 of the *Municipal Act* to be collected by a property value tax as provided in Section 810(1) and 810.1(1) of the said Act; on land only; on improvements only; or on land and improvements, or;
 - (b) the requisition of money under Section 809 and 809.1 of the *Municipal Act* to be collected by a frontage or parcel tax as provided in Section 810(2) and 810.1(2) of the said Act; and
 - (c) the imposition of fees and charges that may be fixed by separate bylaw for the purpose of recovering the costs.
3. The maximum amount that may be requisitioned annually under Section 804(1)(a) shall not exceed Five Hundred Thousand Dollars (\$500,000.00).
4. This Bylaw be cited for all purposes as **"Regional District of North Okanagan - Electoral Area "D" Regional Water Supply and Distribution Local Service Establishment Bylaw No. 1264, 1994"**.

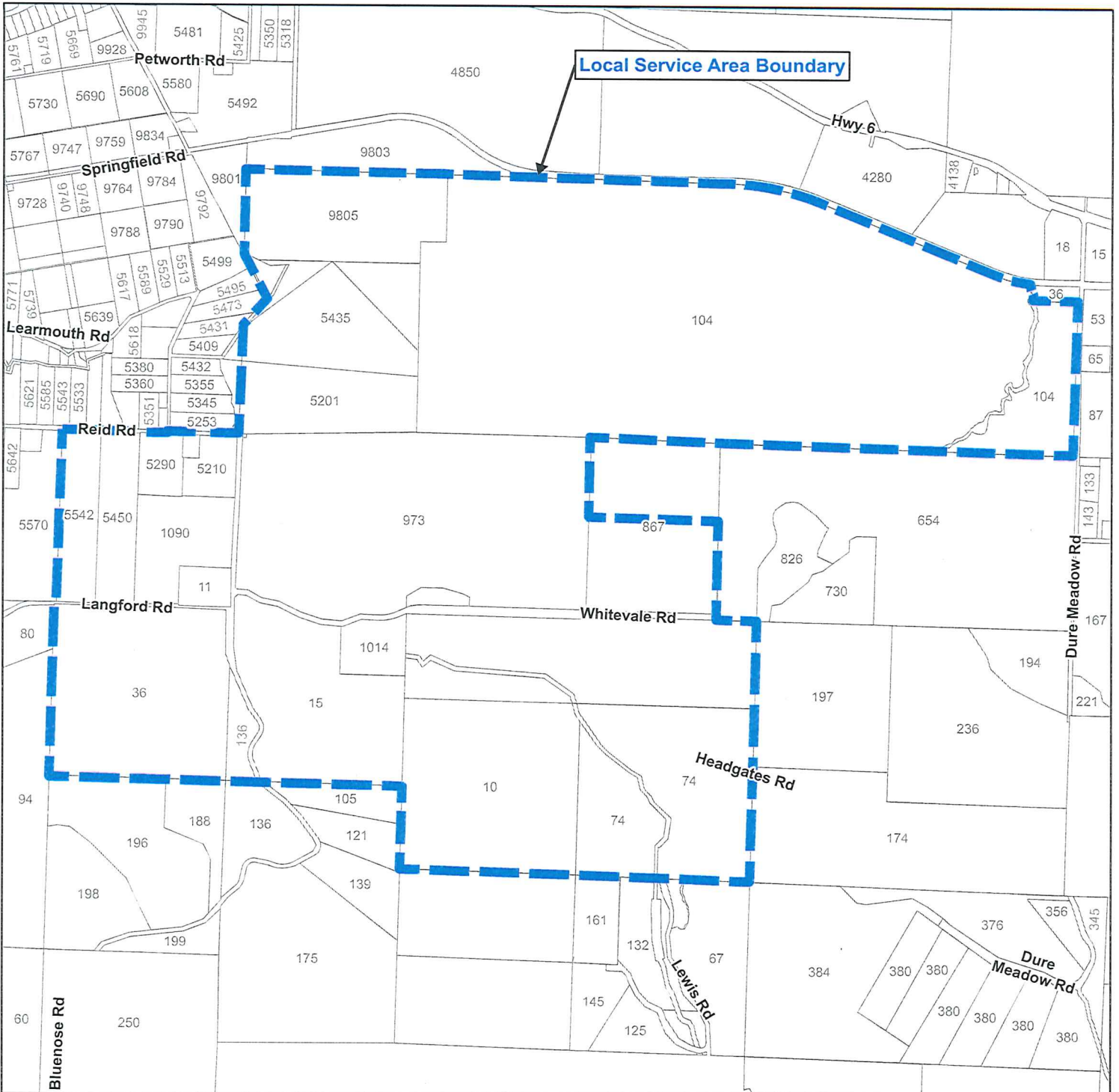
